

STANDARD PRODUCT WARRANTY TERMS

1. SCOPE AND PRECEDENCE

- 1.1. These Warranty Terms ("Terms") apply to all Goods supplied by Swegon Ltd within the United Kingdom and form part of the Contract referenced in the Swegon Order Acknowledgement.
- 1.2. If there is any conflict between these Terms and the Swegon Composite Terms and Conditions of Supply, the provisions of these Terms shall prevail solely in respect of warranty scope, duration and remedies. For all other matters (including price, payment, title, risk, termination, and liability), the Swegon Composite Terms and Conditions of Supply prevail.
- 1.3. Capitalised terms used in these Terms have the meanings given in the Swegon Composite Terms and Conditions of Supply.

2. WARRANTY PERIOD

- 2.1. Unless an extended period has been expressly purchased or stated in the Swegon Order Acknowledgement, the standard warranty period is twelve (12) months commencing on the earlier of:
 - (a) the date of dispatch; or
 - (b) the date the Goods are ready for dispatch where shipment is delayed at the Customer's request.
- 2.2. Time for delivery is not of the essence. The warranty period does not restart, extend or renew on account of any repair or replacement of components, except that any replaced component shall benefit from the unexpired portion of the original warranty period.
- 2.3. Repaired or replacement components are warranted only for the balance of the original warranty period applicable to the Goods and no new or extended warranty period shall apply.

3. WARRANTY COVERAGE

- 3.1. Swegon warrants that the Goods will:
 - (a) conform in all material respects with their description and any specification issued by Swegon to the Customer; and
 - (b) be free from material defects in materials and workmanship during the applicable warranty period.
- 3.2. Subject to the Customer's compliance with these Terms and the Contract, Swegon's sole obligation and the Customer's exclusive remedy for any breach of this warranty is, at Swegon's option, the repair or replacement of defective components. Where necessary to complete the remedy, Swegon will arrange attendance during normal working hours.

4. PRECONDITIONS TO WARRANTY

The warranty applies only where the Customer has complied with all of the following requirements:

- 4.1. The Goods have been commissioned by Swegon, a Swegon-approved installer, or a competent service provider in accordance with the manufacturer's instructions.
- 4.2. The Goods have been operated, serviced and maintained strictly in accordance with the applicable operating and maintenance instructions, and the Customer shall provide documented evidence of such servicing and maintenance upon request.
- 4.3. The Goods have been operated at all times within the specified technical limits, including (where applicable) water and electrical parameters and ambient environmental conditions.
- 4.4. The Customer has complied with all applicable statutory and regulatory requirements, including (where applicable) F-Gas obligations.
- 4.5. Where Goods have not yet been commissioned, the Customer has ensured that such Goods are stored in suitable dry conditions that prevent water ingress, condensation or other environmental damage.

5. EXCLUSIONS FROM WARRANTY

The warranty does not apply to, and Swegon shall have no liability in respect of, any of the following:

- 5.1. Consumable items, including (without limitation) filters, belts, gaskets, lubricants, hoses, bearings, insulation and refrigerant.
- 5.2. Any damage, defect or failure arising from incorrect installation, misapplication, misuse, mishandling, neglect, contamination, corrosion, paint damage, frost damage, inadequate water quality, overheating, overloading, or operation outside the stated technical limits.
- 5.3. Damage caused by transport, storage or handling conditions outside Swegon's control.
- 5.4. Damage caused by external events, including lightning, voltage fluctuations, power outages or similar electrical disturbances.
- 5.5. Any modifications, adjustments or repairs carried out without Swegon's prior written approval.
- 5.6. Any costs incurred without Swegon's prior written approval, including third-party inspections, call-outs or related expenses.

6. CLAIMS PROCEDURE

- 6.1. The Customer shall notify Swegon of any warranty claim promptly and in any event within 10 Business Days of the fault first arising. The notification must include the relevant product identification (model and serial number), a description of the defect, and any supporting evidence such as operational logs or photographs.
- 6.2. A valid Purchase Order ("PO") is required before Swegon arranges any site attendance or issues any replacement components. This requirement may be waived only by a Swegon Director in writing.
- 6.3. Where Swegon requests the return of any failed component, the Customer shall return the item within 30 days in accordance with Swegon's return instructions. High-value components and electronic or control items will generally be required for return.
- 6.4. If, following inspection, Swegon determines that the claim is invalid, Swegon shall notify the Customer. Any further work may proceed only on a chargeable basis and only where the Customer instructs Swegon to continue.

7. WARRANTY REMEDIES AND LIMITATIONS

- 7.1. The Customer's sole and exclusive remedy under these Terms is the repair or replacement of defective components in accordance with Clause 3.2.
- 7.2. Nothing in these Terms alters, limits or extends the limitation-of-liability provisions set out in Swegon's Standard Terms and Conditions of Supply, which continue to apply in full.

8. GOODWILL

- 8.1. Any goodwill provided by Swegon—whether free labour, parts or other assistance outside formal warranty coverage—is entirely discretionary.
- 8.2. Goodwill requests may be subject to internal approval thresholds and escalation requirements. The Customer has no right or entitlement to goodwill.

9. EXTENDED WARRANTY OPTIONS (UP TO 5 YEARS)

- 9.1. Swegon may, by quotation, offer an extended warranty for up to a total of five (5) years' coverage, whether on a parts-only or parts-and-labour basis.
- 9.2. Any extended warranty must be purchased at the time of order and must be expressly stated on the Swegon Order Acknowledgement to be valid.
- 9.3. Extended warranty coverage is conditional on the same preconditions set out in Clause 4 and excludes all items listed in Clause 5.

10. PRODUCT CHANGES

- 10.1. Swegon may introduce design changes, technical updates or component modifications at any time without prior notice and is under no obligation to retrofit such changes to Goods already delivered.

11. GOVERNING TERMS

- 11.1. All other terms of supply—including those relating to delivery, price, payment, title and risk, termination, and limitation of liability—remain governed exclusively by Swegon's Standard Terms and Conditions of Supply. These Terms do not amend or disapply those provisions.
